

#### Lab Advisor Meeting 4 May 2016

Inter-American Development Bank 1350 New York Avenue NW, Washington, Room B300, D.C. 20577 A meeting organized by Climate Policy Initiative on behalf of The Global Innovation Lab for Climate Finance

In its *First Cycle*, The Global Innovation Lab for Climate Finance helped launch four innovative instruments designed to overcome investment barriers in renewable energy, energy efficiency, and adaptation in developing countries. Lab Principals and Advisors endorsed the initiatives this summer, and in the eight months since their endorsement, the initiatives have collectively raised over 500 million USD in initial funding and progressed on their implementation pathways.

With support from the U.S., UK, German, and Dutch governments, Bloomberg Philanthropies, and The Rockefeller Foundation, The Lab launched its *Second Cycle* on 7 October 2015. Of the 99 submissions received, 48 were deemed eligible and Lab Advisors, in consultation with their Principals, selected five final ideas in January 2016 to proceed into the Instrument Design phase, the conclusion of which is marked by the 4 May Advisor meeting.

This meeting convenes Lab Advisors to:

- 1. Review the results of the Instrument Design phase for the five draft Lab Instruments
- 2. Discuss any technical concerns, based on Lab criteria, with instrument designs, noting necessary improvements before beginning the Pilot Support phase
- 3. Endorse the technical design of the instruments, where possible describe how Advisors will offer support, and make recommendations on how the most promising instruments could be specifically piloted through Lab-backed public-private partnerships
  - The Secretariat will summarize the findings of Lab analysis and present possible pathways to implementing pilots, clarifying necessary support including outstanding financial needs/implementation challenges.
  - Public endorsements may also recognize the instrument's potential but recommend additional analysis or partnership building before implementation

It is through this process that potential instruments can be tailored to provide concrete solutions to financing challenges faced in real projects backed by real investors. This in turn can build new markets, attract new investors, and help to unlock billions of dollars in new climate-friendly investment in developing countries.
